Settlement Class Members will receive \$6 multiplied by the square footage of the area to which the Product was applied, multiplied by the percentage of that area that had a Qualifying Problem requiring replacement. If at least 65% of the area to which the Product was applied had a Qualifying Problem requiring replacement then the Settlement Class Member will receive \$6 multiplied by the square footage of the entire area to which the Product was applied.
